Your appeal must include the following:

- 1. A detailed explanation as to why you failed to earn academic credit during the 2015-16, 2016-17, 2017-18 and 2018-19 academic years in which you attended. Your explanation should include why you did not complete (with passing grades) all of your attempted coursework (including dates) and the specific circumstances that prevented you from successfully completing your courses.
- **2.** A detailed explanation of how the circumstances that contributed to you not earning academic credit have since been resolved. Include the steps you have taken to ensure your successful academic progress in the future.
- 3. Attach documentation to support your appeal (e.g. medical claims/statements, police reports, copy of death certification/obituary, signed statement from an involved third party such as a counselor, priest, rabbi, minister, documentation illustrating other commitments outside of school such as pay stubs, letter from employer, etc.).

I am attaching a completed appeal form and supporting documentation as outlined above for review and evaluation by the Financial Aid Office.
